We are fully supportive of implementation of this modification as we agree with the proposer that it will help to ensure appropriate investment signals are received by the DNs and that capacity on the network is available to those Users / end consumers that may require it. This would support DNO compliance with licence obligations in respect of efficient and economic network development and support effective competition between Users (Shippers).

We would also like to take the opportunity to point out that, and to again agree with the proposer, that:

"It is not the intention of this UNC Modification proposal to cause SPORs to fluctuate on an annual basis linked to actual usage, but to ensure the SPOR is an accurate reflection, year on year, of potential maximum hourly capacity requirements."

Implementation of this proposal may also help to identify where Supply Capacity Requirements (SOQ) are not sufficient for a site (or are excessive). This has proven to be a particular issue so far this winter with an above average number of Supply Points incurring Supply Point Ratchet Charges.
