UNC Modification Proposals 0396 'EU Third package: Three week switching' & 0403 'EU Third Package: 21 day switching with flexible objection period'

Dear Bob,

Thank you for your invitation seeking representations with respect to the above Modification Proposals. National Grid Gas Distribution (NGD) would like to support each of these albeit with a preference for 0403.

**Do you support or oppose implementation?**

Support both Modification Proposals.

**Please summarise (in one paragraph) the key reason(s) for your support/opposition.**

NGD supports implementation of either of these Modification Proposals on the basis that they are required to facilitate a new Supplier licence condition requiring suppliers to have the ability to complete a registration of change of supplier within 21 calendar Days. We believe 0403 offers a simpler remedy requiring less significant change to systems and a reduced impact on the UNC hence our preference for that solution.

We have not identified any such issues.

NGD concurs with the statement in the 0403 Draft Modification Report that the Proposal "allows Shippers and Suppliers to meet their respective licence conditions and comply with the requirements of the EU Third Energy Package" and also in the 0396 Draft Modification Report that the Proposal was "raised to facilitate compliance with the Regulation".

Medium level implementation costs would be incurred by Transporters as a consequence of implementing either Modification Proposal. We understand these would be borne by Users under User Pays arrangements.

Systems development work would be required to facilitate implementation of either Modification Proposal.
