Aggregate Results of the completed Bacton Capacity Reallocation Process

Please find the aggregate results of the Bacton Capacity Reallocation showing the aggregated reallocation of NTS Entry Capacity for each of the two new ASEPs within Appendix 1, which details the:

- i. Relevant Months or Quarters
- ii. ASEP
- iii. Quantity in kWh/day allocated

This does not require any User to undertake any actions on National Grid's systems

Please note

- for all Months/Quarters where the aggregated requests are below the Obligated level of either the Bacton UKCS ASEP or the Bacton IP ASEP, the existing Registered NTS Entry Capacity has been fully reallocated to the two new ASEPs as per User requests
- for all Months/Quarters where the aggregate level of NTS Entry Capacity rights requested are above the relevant Obligated level of NTS Entry Capacity at either the Bacton UKCS ASEP or the Bacton IP ASEP, National Grid NTS has allocated the relevant NTS Entry Capacity for that Month/ASEP or Quarter/ASEP combination pro rata the aggregate amount applied for by all Users. The Users' remaining NTS Entry Capacity after the proration has taken place being allocated to the other new Bacton ASEP as relevant

The final reallocation process is now completed and National Grid will, no later than 30th September 2015, update its systems accordingly.

For avoidance of doubt, expressions used within this letter should be interpreted as having the same meaning as per the UNC Document.
