1 Summary

Is this a Self-Governance Modification?

The Modification Panel determined that this is a self-governance modification because it is unlikely to have material effect on gas consumers; competition, the operation of pipe-line systems, safety or security of supply, the uniform network code governance procedures or the network code modification procedures since it only corrects references within the Legal Text of Modification 0548.

Is this a Fast Track Self-Governance Modification?

The Modification Panel determined that this modification meets the Fast Track Self Governance criteria as it is properly a house keeping modification.

Why Change?

In order to ensure that the legal text contained within "Modification 0548 Project Nexus – deferral of Implementation Date" remains commensurate with the intention of the modification and is capable of an easier insertion within the appropriate Transition Document Section, it is proposed that a simple (minor) renumbering exercise is undertaken.

Solution

Amend the Transition Document reference from IIE to IIC and the paragraph numbering from 9 to 20.

Relevant Objectives

This modification would further Relevant Objective f) Promotion of efficiency in the implementation and administration of the Code as it would correct references introduced into Code erroneously.

National Grid Gas Distribution has provided the following Legal Text.

TRANSITION DOCUMENT - PART IIC

Move text inserted as a new paragraph 9 in Transition Document Part IIE (pursuant to Modification 0548) to a new paragraph 20 in Transition Document Part IIC to read as follows:

20 Project Nexus Implementation Date

- 20.1 For the purposes of this paragraph 20 "**PwC Implementation Plan**" is the plan of that name prepared by PwC relating to the implementation of the Transporter Agency's UK Link replacement programme.
- 20.2 Each Party acknowledges the following system trials (each more particularly described in the PwC Implementation Plan), to support implementation of Modifications 0432, 0434 and 0440, need to be undertaken and completed in accordance with the following timetable:
 - (a) Solution Readiness:
 - (i) L2 entry readiness criteria to be completed by 1 October 2015;
 - (ii) L3 entry readiness criteria to be completed by 31 December 2015;
 - (b) Level 2 File Structure Trials to be undertaken and completed in the period between 2 November and 18 December 2015;
 - (c) Level 3 Functional Market Trials:
 - in respect of the changes needed to support implementation of Modifications 0432 and 0440, to be undertaken and completed in the period between 1 February and 27 May 2016;
 - (ii) in respect of the changes needed to support implementation of Modifications 0434, to be undertaken and completed in the period between 2 June and 29 July 2016;
 - (d) Level 4 Multi-Party Market Trials:
 - in respect of the changes needed to support implementation of Modifications 0432 and 0440, to be undertaken and completed in the period between 1 February and 27 May 2016;
 - (ii) in respect of the changes needed to support implementation of Modifications
 0434, to be undertaken and completed in the period between 2 June and 29
 July 2016.
- 20.3 Each Party agrees to use best endeavours in supporting completion of the system trials in accordance with the dates and timetable in paragraph 20.2.
- The dates and timetable in paragraph 20.2 will be subject to on-going review in accordance with the procedures set out in the PwC Implementation Plan, however the dates and timetable in paragraph 20.2-may only be changed with the approval of the Authority.

8 Panel Discussions

The Panel Chair summarised that Modification 0556FT is a house keeping modification that seeks to correct reference numbering errors in order to ensure that the legal text contained within "Modification 0548 Project Nexus – deferral of Implementation Date" remains commensurate with the intention of the modification and is capable of insertion within the appropriate Transition Document Section.

Members considered the relevant objectives, agreeing that implementation would further objective f) promotion of efficiency in implementation and administration of the Code, as it would correct earlier errors and enable the Legal Text of Modification 0548 to be written into the Code.

Members voted unanimously to recommend implementation of Modification 0556FT.
