## Key Points/Decisions

1. The Workgroup approved the summary of Workgroup discussions held on Thursday 14 February 2019.
2. The Workgroup reviewed all current Actions providing appropriate updates.
3. No pre-modifications were raised. PG reminded the Workgroup of the importance of submitting any potential Alternative Modifications. The Modification Panel will convene on Thursday 21 February 2019.
4. GJ introduced his compliance comparison assessment for Modification 0678C.

During discussions the following key elements were considered (by exception):

**Article 6** – for clarification CWi advised how the model will work with regards to Reference Price Methodology (RPM), this is quite a complicated calculation, and is an option that can be included in to the model.

The CWD calculation, the mechanics of how the model calculates. Workgroup agreed for GJ to alter the wording around the sentence “multiplying by a constant with the aim of setting charges to recover”.

**Article 7:** It was confirmed that the cost of compressors, the asset cost, would be Transmission Services.

**Article 9:** GJ confirmed he is open minded about the % split quoted, 50% discount for Storage facilities and 0% for LNG facilities. GJ would be prepared to consider something should it be highlighted to him.

**Article 12:** RF asked for clarification with regards to the tariffs to be applied.

Ofgem clarified, this has been discussed at previous meetings and Ofgem are working through this as modifications develop.

JCh raised specific points with regards to signalling or surrendering capacity during the July Auctions and stated that, during the first 2 weeks of July, if the Industry know in advance the price of contracts, then the Industry can plan for their business requirements accordingly.

GJ confirmed this should be a well-managed implementation to enable planning for business requirements.

PG asked that all Proposers of all Modifications should produce their compliance assessment in the same format as submitted by 0678A and 0678B.

For clarification the three issues highlighted by Ofgem in their Modification 0621 decision letter were confirmed:

- The creation of ‘interim contracts
- The content of the proposed ‘transition period’; and
- The NTS Optional Charge.

## 5. Workgroup Report

The Workgroup considered wording for the Workgroup Report and a live update was completed. Consideration was given to the Compliance Assessments provided for 0678A and 0678B and Workgroup provided appropriate wording and produced a statement for inclusion in the Workgroup Report.

<b>Action 01-1802:</b> Any firm statements to be included in the Compliance section for Modifications that are currently live are to be provided by 22 February 2019 (Target date <b>22 February 2019</b> )

<b>Action 02-1802:</b> Any firm statements to be included in the Compliance section for Modifications that are NOT currently live are to be provided by <b>01 March 2019</b> (Target date <b>01 March 2019</b> )

When asked, it was confirmed that Modification 0678B does not inhibit any Shipper User from accessing the Optional Capacity Charge.

The Workgroup discussed at length the risk of interruptions and the discount that would be applied. If a User is buying Interruptible capacity, then that User is buying the risk of interruption.

The Workgroup went on to discuss the following issues raised by RF:

### Shorthaul

There are no rules at the moment for a User to come off the existing offer from National Grid relating to Shorthaul.

RF advised he would like to see some Rules on how Users can be taken off the existing Shorthaul rate.

GJ clarified that there is a section in 0678B Optional Capacity Charge solution (Transition Arrangements) that might not should be adequate, but RF will review.

### Historical Contracts

When capacity is traded, Article 35 protects capacity contracts that are concluded prior to 06 April 2017.

For example, if in 2010 some capacity was traded that was purchased in 2008, would that capacity receive special treatment under any of the Modifications that 0678 has currently.

CWi confirmed that for Storage, if Capacity is traded up until 6 April 2017 it is protected, anything after that date is not protected.
