**RE: Final NTS Exit (Flat) Capacity Charges effective from 1st October 2021, and Indicative NTS Exit (Flat) Capacity Charges for 'Bacton (exit) IP, following the decision to modify National Grid Gas Plc's Gas Transporter Licence to amend special condition 9.13, Appendix 2: combining of two existing NTS Exit Points.**

Following the Authorities decision to modify Special Condition 9.13, Appendix 2 of the Gas Transporter Licence ("the Licence") held by National Grid Gas Plc ("NGG"), with effect from 15<sup>th</sup> December 2021, National Grid is publishing this note to confirm the Exit Capacity Reserve Prices for the new Exit Point, Bacton (exit) IP.

The following prices are applicable for the Exit Annual Yearly IP Capacity Auctions, Exit Annual Quarterly IP Capacity Auctions, Exit Rolling Monthly IP Capacity Auctions, Exit Rolling Day Ahead IP Capacity Auctions and Within Day IP Capacity Auctions once UNC modification 0785 is implemented. The price, per the pricing Postage Stamp methodology, is unchanged.
