1. Introduction

3. Matters for Committee Attention

3.1 Annual Review 2023 - Consultation Feedback

Rachel Clarke (RC) provided an overview of the 2022/2023 Annual Review & Engagement Event Report advising that this is now an industry event to specifically engage with the industry and had been changed to an online survey for better accessibility. It has received more engagement than methods used in previous years.

RC provided a view of the 2023 Annual Review feedback received and the response in each case.

When SM asked, RC agreed to refer to the Performance Assurance Parties (PAP) as either 'parties' or 'stakeholders' rather than PAP.

PAC members discussed the comments made regarding out-of-date data. Fiona Cottam (FC) noted that the main cause for a delay to more up-to-date data is the read performance with a 25 business day window for meter reads to be submitted.

FC took action to revisit the CDSP response to Q6.

New Action: CDSP FC: to rephrase the response *from* CDSP where it is suggested that *the* retrospective nature of PAC reports means that by the time data is presented at PAC it is around 6 to 10 weeks out of date.

The members discussed various ways of how, if at all, the data presented can be more up-to-date, and it was suggested that Agile Working is discussed at the December 2023 PAC meeting.

In the interest of time, it was suggested, that the rest of the report will be reviewed at the December meeting.

3.2 Appeals Process

RC explained that Entry and Exit criteria have been discussed previously and the Appeals Process is an area that has come out of those discussions for PAC consideration.

Existing Disputes Process

RC explained the existing process is only used for very specific situations and asked PAC Members to consider if the existing process is applicable.

Further areas of consideration

RC asked of the PAC members, is this appeals process appropriate for appeals against Performance Improvements Plans (PIPs) or is there an alternative appeal approach that can be used.

It was confirmed that a Modification would need to be raised should the scope of paragraph 16.8.1 need to be increased.

When it was noted that it is quite an onerous process for appeal, RC suggested including that PAFA and the party can work collaboratively to overcome any issues in the first instance.

RC noted that generally, parties are good at keeping PAFA informed and that PAFA would provide PAC with regular updates.

PAC members agreed that if and when the Appeals Process needs to be utilised, the discussion can be re-opened.

4. Monthly Performance Assurance Review Items

PARR – Shipper Performance Analysis (Holistic Matrix)

Holistic Performance Assurance Matrix (HPM):

PAFA provided an update in terms of the output of the HPM in the four Product Class categories and also provided an update in respect of Performance Improvement Plans (PIPs).

Three new Parties have fallen on or below the Performance Improvement Plan criteria for Product Class 3. PAC voted to issue these Parties with a PIP.

It was noted that two Shippers previously issued with a request for a Product Class 3 PIP have shown an extremely positive shift in their HPM score and overall performance. PAFA recommended that PAFA's 'active' monitoring of the Party against their agreed Plan be discontinued while the Party continues implementing it. PAC were in favour of this approach and letters will be issued to Shippers to advise of this outcome.

To encourage continuous performance improvement, PAC plan to keep the Holistic Performance Matrix (HPM) scores and thresholds under review. The PAC were shown graphs of the distribution of Shipper scores in the HPM in each Product Class. In each graph the proportion of shippers meeting UNC requirements for the factors incorporated in the HPM are shown on the extreme right and the poor performing Shipper outliers are shown towards the left.


POOR PERFORMERS IN EACH MARKET











Discussions were undertaken on Parties falling just above the agreed score threshold with suggestions about how and when to request resolution plans from these Parties. The pre-Performance Assurance Technique (PAT) application engagement route as presented, discussed and agreed at the October PAC was reviewed in the context of these Parties. PAC was in favour of issuing letters to these Parties to highlight their low scores over the previous three months.

CDSP confirmed that Read Performance in Product Class 1 has recently seen a big improvement and is looking positive.

The PAFA confirmed that they are currently reviewing options regarding the HPM and accessibility to the industry

4.1 Risk & Issues Register Update - deferred to December meeting

The Risks and Issues Register Update agenda item was by exception for this month. As there were no significant issues to highlight no updates were provided, however, the presentation is available for review here.

The presentation highlights seven risks for November 2023:

PC3 Reads

33% decrease in Value at Risk across 2022-23 due to a combination of an increase in Read Performance and a decrease in the average number of sites and associated average AQ.

The Risk Rating in the register is 3 (medium priority).

PAFA will continue to monitor closely. The next Review refresh point is February 2024.

PC4 Monthly Reads

- 8% decrease in Value at Risk across 2022-23 due to an increase in Read Performance.
- The Risk Rating in the register is 5 (highest priority).
- PAFA will continue to monitor closely. The next Review refresh point is February 2024.

PC4 Annual Reads

- 31% decrease in Value at Risk across 2022-23 due to a combination of an increase in Read Performance and a decrease in the average number of sites and associated average AQ.
- The Risk Rating in the register is 5 (highest priority).
- PAFA will continue to monitor closely. The next Review refresh point is February 2024.

AMR Monthly Reads

- 27% decrease in Value at Risk across 2022-23 due to a combination of an increase in Read Performance and decrease in the associated average AQ.
- The Risk Rating in the register is 2 (lower Priority).
- Review at next refresh point of February 2024.

AMR Annual Reads

- 111% increase in Value at Risk across 2022-23 due to a combination of a decrease in Read Performance and substantial increase in the associated average AQ.
- The Risk Rating in the register is 2 (lower priority).
- The next Review refresh point is February 2024.

Rejected PC4 Annual Reads

 28% decrease in Value at Risk across 2022-23 due to a combination of the decrease of rejected read volumes, the number of Supply Points (SPs) within this category and the associated average AQ.

- The Risk Rating in the register is 3 (medium priority).
- The next Review refresh point is February 2024.

Rejected PC4 Monthly Reads

- 119% increase in Value at Risk across 2022-23 due to a combination of the increase of rejected read volumes, the number of SPs within this category and the associated average AQ.
- The Risk Rating in the register is 3 (medium priority).

PAFA presented PAC with an overview of AQ at Risk calculations and how these are undertaken by the CDSP, as previously requested by Shipper Parties.

PAC raised concerns around AQ at Risk and the potential to disproportionately disadvantage larger portfolios. Suggestions raised included PAFA highlighting to Parties with certain sites with high AQs that may be problematic to Settlement to establish reasons for No Reads.

PAFA requested PAC email PAFA (PAFA@gemserv.com) with any suggestions or questions in relation to AQ at Risk/PARR Reports.
