
- Overall Status ON TARGET
- Progress Summary
 - Proposed AUGS presented to AUG Sub-committee 10 Jan 2020
 - Consultation period now closed
 - 2 Responses received
 - Data & Topic Status published on JoT
 - Telecon to discuss AUGE input to support Mod693R
 - Data Provision ongoing
 - Updated data request issued for additional TRAS data (leads)
 - 95% of expected files received to date
 - Request to IGTs for information on unknown (rejected) CSEPs

Progress Summary

- Progress Summary continued
 - One analysis topic not completed (Topic 35 UG from Meter Exchange)
 - Updated data set received but CDSP reports some missing data for most recent period and are investigating
 - 3 Further Topics on hold
 - Topic 55, Creation of New EUCs awaiting UNC modification to implement and view of AUG Sub-committee re, timelines
 - Topic 65, Impact of updated CWV definition data not available until Sept 2020 (WAALPs)
 - Topic 66, Assessment of TRAS leads data awaiting data
- Risks
 - No major risks identified

Analysis Progress Update

- Theft Analysis (Topic 8)
 - Analysis complete
 - TIG agreed in principle that the Lead data could be released 'for information' initially to allow the AUGE to appraise the data
 - Updated data request outlining the proposed analysis issued
- Use of Static Correction Factors (Topic 25)
 - Telecon held with Scottish Power, JoT & CDSP to discuss Mod693R
- Meter Exchange (Topic 35)
 - Feedback from CDSP indicated that meter exchange data was not complete and provided an updated set of data which addressed the sample issues previously identified
 - However, CDSP reported that there are still some missing reads for the most recent data set and are investigating
