126	Xoserve to produce a "Straw Man" for a process for desk-top investigations to be carried out before DN site visits were instigated with a view to setting aged MPRNs to EX. (by end of August) Update 19 th September – MES presented a proposal for desktop investigation (See Appendix 1). The group approved this approach with minor amendments and additions. Xoserve to proceed and report back to group at next meeting. Update 5 th December – Findings were presented to the Workgroup. It was concluded that site visits would be required to validate the desktop investigation findings. Networks maintained that they were not in a position to conduct site visits at this time. Minutes

1. Introductions

LJ welcomed the group and introductions were carried out. He went on to present the agenda items.

2. MPRN Creation work group

2.1 Network Code Modification Update

CW gave an update on 4 S&U relevant MODs: MOD424, MOD425, MOD410 and MOD410a. Details can be found on the Joint Office Website.

2.2 MPRN Creation Process Change Update

DM and EM gave an update on the industry consultation for the proposed MPRN Creation Process. DM talked through the process flow diagram and delegates were invited to raise questions and comments. These are collated in **Appendix 1**.

IG reported that some DNs insist on a new MPRN for a service alteration. The group recalled that the scenarios for new MPRN creation had been discussed and resolved at a previous meeting and agreed to republish the findings.

Action 138 – Xoserve to republish the slides that indicated when a new MPRN creation is required.

IG noted that UIPs do not have access to all necessary Xoserve systems.

Action 139 - Xoserve to investigate if UIPs can have access to Data Enquiry.

2.3 MPRNs Set to DE/EX in Error

Action 137 was discussed. The DNs maintained that there was not a significant issue with MPRNs being set to DE in error.

LJ described the circumstances under which Xoserve would set an MPRN to DE. These were solely at the request of a Shipper, and only conducted after validation and after confirmation from the relevant DN that the service is DEAD.

DW stated that she had done some analysis of a small sample of MPRN creation requests (MNCs) and found that 50% of the small sample was created because an existing MPRN had been set to DE in error.

Action 140 - Xoserve agreed to conduct analysis on 25 valid MNCs to determine why the requests were required.

3. Actions from Previous Meetings

LJ ran through all previous actions. (See updates above)

4. Stats and Unregistered Reports

LJ presented through the industry statistics. (See Meeting Slides).

Previous Action 131 - LJ presented age profiles for Shipperless Sites using the Confirmation End Date instead of the MPRN Creation Date.

Previous Action 132 – LJ presented statistics in a "Received, Cleared, Outstanding" format.

CW asked if it was necessary to include the numbers of Legitimately Unregistered and Created <365 in the Shipperless and Unregistered statistics. AJ said that it is useful to see the whole Shipperless and Unregistered population presented in the statistics.

Action 141 – Xoserve agreed to examine ways to present the statistics to meet both requirements.

5. Population Cleansing "Strawman" Proposal Update

LJ presented an update on the desktop investigations that Xoserve conducted to determine whether "Aged" MPRNs could be set to EX "en mass". (See meeting Slides)

It was found that no decision could be reached without a site visit for 71% of the sample of 100 MPRNs.

AJ raised an issue that the Networks had agreed to visit the sites relating to the sample of 100 MPRNs to verify the findings from the desktop exercise. The Networks reported that they were not currently in a position to conduct the site visits.

LF suggested that site visits could be conducted on 27 sites from the sample. The Networks maintained that they were not in a position to conduct any site visits.

Action 142 – Networks to discuss what activities they could conduct to meet the requirements of the exercise.

6. End User Letter Update

LJ gave an update on the End User Letter Exercise. The previous exercise revealed a 20% Nomination / Confirmation Rate. This was encouraging and it was suggested in the last meeting to continue with further End User Lettering. Xoserve engaged with the DNs to discuss the way forward an d were advised by the DNs that funding would not be available for this work.

The group maintained that this would be worth pursuing. All DNs agreed to engage with Xoserve to consider reintroducing the End User Letter process.

7. Shipperless and Unregistered "Pot" Priorities

LJ suggested that due to time constraints, this agenda item should be carried forward to the next meeting. The group agreed.
