Minutes

1. Introductions

LJ welcomed the group presented the agenda items and initiated introductions across the group.

2. Actions from Previous Meetings

LJ ran through all previous actions. (See updates above)

3. Statistical Information

MES presented the latest available statistics.

4. MOD 518 Process

LJ presented a background to the MOD518 GSR Reporting Process.

RB stated that Shipper activity in this area is a positive thing, as it could prevent unnecessary site visits for the Networks, which could result in charges to Shippers.

OB asked if Shippers were checking the reports to ensure that the address details held were accurate. WWU had experienced poor address information on the GSR Reports which had caused aborted site visits.

It was noted by many of the group that since the implementation of GDPR, some organisations had been reluctant to share information with others. This has hampered issue resolution.

Action 200: Shippers and Networks to confirm within their respective organisations, the policies in place for sharing pertinent information with other gas industry participants.

It was also noted that contact details held for various Shipperless and Unregistered Sites related activities were in some cases out of date.

Action 201: Xoserve (MES) to re-issue the Contact List to all Shippers and Networks to obtain up to date information.

Action 202: Shippers and Networks to provide up to date contact information

KE stated that EDF had received erroneous confirmation from their MAM that meters had been removed. AM said this had also happened with SSE's MAM.

5. Plot to Postal Process

LJ gave a description of Xoserve's Plot to Postal process and summarised the monthly statistics.

Some members of the group indicated that they did not think the report was being issued to the correct people.

Action 203: Xoserve to issue the Plot to Postal distribution list to the group for its review.

Action 204: Shippers and Networks to review the distribution list for the Plot to Postal report.

Challenges were made as to the accuracy of the Plot to Postal statistics, as from Nov'17 the number amended didn't correlate to the number of alternative addresses provided.

Action 205: Xoserve to review the statistics and advise accordingly.

LWar high-lighted the fact that Ofgem had indicated that it would approve a compensation payment of £30 to end consumers every time there was a problem with switching supplier. Incorrect address details are one of the main reasons for switching issues.

6. Modification 0431

MES gave a summary of the recent portfolio reconciliation project.

7. AOB

• OB requested that the AQ be added to the monthly S&U reporting suite. This triggered a discussion around the reporting review/rationalisation process which took place circa 2 years earlier. MES

- advised that any subsequent changes would need to be agreed across the group and that to instigate this piece of work a Change would be required.
- LW / MT noted that the last few MOD675 (Network Isolation Reports) had been "nil returns"
