**1.0 Outline of Modification**

Steve Mulinganie (SM) introduced the Modification and explained this is an administrative Modification to align the Allocation of Unidentified Gas (AUG) Table in Uniform Network Code (UNC) with revisions to EUC bands amended by a change to the DSC.

Alan Raper (AR) advised that Uniform Network Code (UNC) would need to accommodate both tables and asked the Workgroup if the existing table would need to be end dated. RP confirmed that the existing table will run for the current gas year. The new table will start at the beginning of the next gas year (October 2020); however, the Allocation of Unidentified Gas Expert (AUGE) would need to plan to accommodate and reference to the new AUG Table in the interim.

Kirsty Dudley (KD) asked, for any future changes, how this process can be made so that there is no requirement for a Modification to be raised.

In response, SM commented that it was recognised how commercially sensitive the AUGE process is, therefore, changes to the table require a UNC-governed Modification. KD clarified that going forward, it needs to be easier to implement changes to this table.

Dave Addison (DA) provided clarification to the Workgroup that it is anticipated this would be a 2021 implementation as it is a very complex change and it is quite likely that the AUGE will not have contemplated this as part of the tendering process.

With regards to implementation, SM will liaise with the AUGE to see to clarify the optimum method for deploying the new table.

**New Action 1101:** SM to liaise with AUGE to confirm the Gas Year to which the new table should apply.

**New Action 1102:** Xoserve to provide detail on the system changes required to implement the proposal.
