Section 1: In Scope

The delivery of assurance activities associated with UNC mod 0841:

"The scope of the assurance activities shall include:

• an assessment of the extent to which the Business Plan Information Rules (https://www.gasgovernance.co.uk/dl-mod-attachment/a84edca3-622d-4c42-a447-377791472f3f) have been satisfied in the final version of the CDSP Budget and the supporting material."

Solution

This will be an exercise that assesses how compliant we are versus the Business Plan Information Rules (BPIRs).

There will be a requirement to determine whether each BPIR has been 'fully', 'partially' or 'not' satisfied in each of the iterative drafts of BP25. Where compliance is less than 'full', the required management reports should suggest measures that could be taken to achieve 'full' compliance. We expect that the assurance burden will reduce with each draft of the business plan, with Draft 1 being fully assessed (given the content is all 'new') and subsequent drafts (2 and Final) containing less 'new' or 'revised' content that requires new / further assessment – when we produce draft 2 we will highlight any changes from Draft 1 (e.g. inspired by Xosereve's response to assurance provider / stakeholder suggestions to achieve full compliance) which will enable the assuance provider to focus on 'new' aspects of each iterative draft rather than the whole document.

It is important that the Final Draft ('F') of BP25 is fully assured, with any 'new' content (between Drafts 1,2 and F) being assessed versus the BPIRs. Xoserve's experience in producing business plans is that document content changes aren't wholesale and reduce with each iterative draft. As such, we expect that the most time and effort will be required during the assessment of Draft 1 and then (to a lesser degree) the assessment of the changes we have made to subsequent drafts in order to achieve full BPIR

compliance. However, the assessment of compliance that will be carried forth into our final assessment of compliance versus the BPIRs will be based on Draft Final of BP25 (following the iterative process set out above).

Outputs

We will use the outputs (management information reports) of each requirement to present to the Xoserve Executive Team and representative customers at the DSC Contract Management Committee (CoMC) in September (Draft 1), November (Draft2) and December (Draft F) 2024. The reports will be published alongside each iterative draft of BP25 (excluding SP&P). A final summary of compliance with the BPIRs will form part of the Xoserve Board Assurance Statement which will be included in the body of BP25 Draft Final.

Section 2: Out of Scope

A separate procurement activity will be undertaken to satisfy the second assurance element in the modification:

Proportionate checks (for example through a sampling approach as the third-party assurance provider may
advise or other standard practice) to validate the accuracy and consistency of the numbers presented in the
CDSP Budget and the supporting material.


