





Status Justification

There is a risk that the start of Market Trials is delayed due to the dependency on system components completing the full development and test cycles, including End to End testing in advance. There are some small delays in these processes which may have a knock on impact to the start of MT

- 1. Prioritise Market Trials components in the functional Development and testing backlogs
- 2. Tag Market Trials User stories
- 3. Prioritise E2E scenarios that are needed for Market Trials

There is a risk that should the target September implementation date be deferred; the Programme will be impacted by the constraints of the Winter period.

- 1. Monitor the ongoing velocity of development and testing and flag slippage in planned targets to Programme management.
- 2. Maintain the focus on defect resolution and daily reporting.
- 3. Bolster the programme structure with additional resource to focus on test management and defect resolution.
- 4. Review current activities across the wider programme to ensure sufficient focus on priority areas.


