PART IIC – TRANSITIONAL RULES¹

1. UNIFORM NETWORK CODE

- 1.12 TPD Section E: Unidentified Gas - Allocation Factors
- 1.12.1 The activities set out in TPD Section E, paragraphs 9.4.1 to 9.4.3 shall not be performed in:
- (a) the period from 1 June 2025 until the end of the AUG Years Year beginning 1 October 2025 and to the extent those activities relate to the publication of an AUG Table for the AUG Year beginning 1 October 2026 in order;

to produce an AUG Table for AUG Years(b) the period from 1 June 2026 until the end of the AUG Year beginning 1 October 2026 and to the extent those activities relate to the publication of an AUG Table for the AUG Year beginning 1 October 2027 respectively,

although pursuant to 1.12.2 to 1.12.4 to 1.12.6 those activities shall be performed, and an AUG Table shall be published, in respect of for the AUG Years beginning 1 October 2026 and 1 October 2027.

1.12.2 In the AUG Year beginning 1 October 2024:

- 1.12.2 For the avoidance of doubt, the activities set out in TPD Section E, paragraphs 9.4.1 to 9.4.3 shall be performed on and after 1 June 2027 to the extent those activities relate to the publication of an AUG Table for the AUG Year beginning 1 October 2028.
- 1.12.3 In the period from 1 June 2024 until the end of the AUG Year beginning 1 October 2024, the AUG Expert, the Committee, each Transporter and each User shall to the extent their activities relate to the publication of an AUG Table for the AUG Year beginning 1 October 2025:
- (a) read the reference to "In respect of each AUG Year" in TPD Section E paragraph 9.4.3 shall beread as "in In respect of the AUG Years beginning 1 October 2025, 1 October 2026 and 1 October 2027" and, accordingly, the AUG Table published by the Committee in the AUG Year beginning 1 October 2024 pursuant to TPD Section E paragraph 9.4.3(i) shall apply in respect of the AUG Years beginning 1 October 2025, 1 October 2026 and 1 October 2027; and
- (b) read references to "For each AUG Year" in TPD Section E paragraphs 9.4.1 and 9.4.2 shall be read as "In respect of For the AUG Years beginning 1 October 2025, 1 October 2026 and 1 October 2027".1.12.3
- 1.12.4 The AUG Table referred to at paragraph 1.12.21.12.3(a) shall, for the purposes of TPD Section E, paragraph 9.4.4(a), be deemed to be the AUG Table established for the relevant AUG Year(s) for the purposes of TPD Section E paragraph 9.4.1, and no further approval of the same by the Committee as envisaged by TPD Section E paragraph 9.4.4(a) shall be required forduring the AUG Years beginning 1 October 20262025 or 1 October 20272026.

1.12.41.12.5 Not later than the date of each of the:

- (a) April 2026; and
- (b) April 2027

meeting of the Uniform Network Code Committee, CDSP shall inform the Uniform Network Code Committee of the AUG Table that that will apply from the start of the upcoming AUG Year.

1.12.6 This paragraph 1.12 shall apply until and including 30 September 2028.
