249.6. Matters for the Committee's Attention

a) Review of the AUG Year 2023/24

F Cottam (FC) presented the AUG Year Review Report for 2023/24 to the Committee. FC explained that this is an annual process and the request for feedback on the AUG (Allocation of Unidentified Gas) Year 2023/24 process was requested on 17 May 2024 with responses requested to be provided by 10 June 2024. FC confirmed that they have received responses from Shipper organisations and the AUGE.

FC noted some concerns raised in the comments regarding low attendance at some AUG Sub-Committee meetings. The Committee discussed the low attendance and suggested that re-structuring the discussions in the meeting could invite more people to attend.

FC highlighted the AUGE's response in relation to Modification 0868 where it advised that although it monitors relevant industry change with interest, it generally remains impartial to discussions unless invited to contribute expertise. FC advised that the AUGE has been invited to attend the recent 0868 Workgroup meetings in an advisory capacity and AUGE has provided constructive feedback. This will continue for future sessions where possible.

b) Gemini Update

M Montgomery (MM) provided an update on Gemini Sustain Plus. MM advised that a decision has been made to confirm that the September implementation timeline and Go-Live date is no longer achievable. MM confirmed that a new delivery plan is being worked out, however, the delivery date cannot be confirmed at this stage.

The Chair queried how much of a delay is expected. MM was unable to provide a timeline at this stage and advised that a wide range of options are being looked at. MM noted that this is discussed in the monthly Gemini Working Group in detail, with updates also provided at the DSC Change Management Committee.

A Committee Member noted that a Working Group was arranged, however, the meeting was cancelled. MM advised that this was cancelled due to the change in the timeline.
