1.0 Outline of Modification

Mark Jones (MJ) provided an overview of the Modification, advising that there was originally no cut-off date until 2008.

SSE are considering the product classes and obtaining further meter readings to move towards a shorter Line in the Sand (LIS) in the future.

2.0 Initial Discussion

2.1. Issues and Questions from Panel

2.1.1. If there is agreed to be a move to the new LIS, will Shippers have to clear all outstanding issues first, or will these remain as legacy issues under the existing timeframe?

This item was deferred until September 2024.

2.1.2. Will there still be a reopener beyond the 3 year rolling date if there are valid claims between 3 years and the statutory 6 years?

MJ advised that the answer to this question is likely to be no however, he is unsure of how this will be impacted by the Modification. It was noted that the comment about the statutory 6 years equally applies to the process as it currently stands

2.1.3. Consider consequential impacts of moving to monthly billing

This item was deferred until September 2024.

2.1.4. Has the CDSP analysed the impact of the change of approach in particular on other less frequent activities i.e. no unintended consequences arise

Kathryn Adeseye (KA) advised that this question is not something that could be answered straightaway and that an assessment will be required to understand the real benefit and value to the Workgroup to drive discussions. CDSP will consider looking into this assessment.

Workgroup considered the Solution in the Modification and Kate Elleman (KE) provided an overview to see if any further information was required in addition to the presentation pack. The invoicing timetable was mentioned however, as Fiona Cottam was no longer in attendance for this Workgroup, there was nothing further discussed.

New Action 0801: CDSP (KA) to conduct an Initial Impact Assessment and discuss with the Proposer to consider how to progress the Modification.

It was agreed that it is too early to consider a Rough Order of Magnitude (ROM), however consideration will need to be given to the amount of work required on a monthly basis and whether this Modification will be included in a Release or as a stand-alone Release.
