**1. Outline of Modification**

Steve Mulinganie (SM) queried whether the reference to “domestic” has been removed however, Lee Greenwood (LG) confirmed he has not yet done this.

Kate Elleman (KE) requested for an updated version of the Modification to be provided for publication to reflect the amended date from Panel and the amendment above.

LG provided an overview of the Modification advising that this is in relation to amending the AQ Correction Process. The Proposer had considered the feedback from the Workgroup and decided to withdraw the previous Modification and raise Modification 0890 to address areas more specifically where issues are being seen. Modification 0890 will consider creating a new AQ Correction Code following a request for adjustment.

KE advised that additional material will be useful for the Workgroup from an educational perspective ahead of the substantial discussions to be had.

LG highlighted the questions from Panel, one being in relation to considering the AQ Correction Code to ensure that there is not currently an existing mechanism which could be utilised instead. LG advised he does not think there is any duplication, however, this will be considered alongside the RFI.

The Modification initially reported to Panel as Self-Governance. Upon voting there was a tie and the Independent Chair decided that this Modification should be authority direction. KE highlighted that if there is substantial evidence to suggest self-governance is more appropriate, this can be reported back to Panel to re-assess.

The process for Modification 0890 is likely to follow the same process as Modification 0866 which has had a Rough Order of Magnitude (ROM) and an impact Assessment. CDSP will work with Centrica to review the RFI process as an education piece due to the operational aspect, however, it was confirmed by Josie Lewis (JL) that there is no planned Impact Assessment for this Modification at this stage.
